Definitions

- **a.** Company: As used in this statement of assurance, "company" means the corporation, partnership, or other legal organization that has separate existence and can function legally, including, without limitation, its subsidiaries, divisions, agents, and employees.
- **b. Animal Testing:** As used in the statement of assurance, "animal testing" means all testing of finished cosmetics and/or household products or any one or more ingredients or formulations used in the manufacturing or production of such products, in which whole nonhuman animals are the test subjects, including, without limitation, fish, amphibians, reptiles, birds, and nonhuman mammals. Animal testing excludes *in vitro* tests or tests conducted completely with human volunteers.
- **c. Cosmetics:** As used in the statement of assurance, "cosmetics" means those products identified as cosmetics in the <u>Federal Food, Drug, and Cosmetic Act</u>, including, without limitation, products for the hair (e.g., shampoo, conditioner, coloring agents, depilatory agents), skin (e.g., soap, moisturizer, sunscreen, aftershave, antiperspirant, deodorant, talcum powder, bubble bath), mouth (e.g., toothpaste, mouthwash), and nails (e.g., nail polish, polish remover) as well as perfume, cologne, lipstick, eye shadow and liner, and rouge. "Cosmetics" also includes products marketed or regulated as over-the-counter drugs (e.g., toothpaste marketed with the claim of preventing cavities and mouthwash marketed with the claim of killing germs).
- **d. Household Products:** As used in the statement of assurance, "household products" means those products identified as household products in the Consumer Product Safety Act, including, without limitation, laundry and dish detergent, bleach, cleaners and cleansers, floor wax, furniture polish, air freshener, correction fluid, ink, glue, and toys. Regarding ink and glue, the statement applies only to the manufacture of these items, not to their incidental use in the product assembly and packaging.
